AWARD

These are the three cases filed by Workman under section- 2(A) of I.D. Act for their illegal termination. These cases are taken together because in the present cases, issues are same, respondents are the same against whom, the reliefs are sought . Claimant Deepak and Arun Kumar claimed to have working at the post of workmen since 1/03/2017 and September 2016 with the respondents at the last drawn wages at the rate of Rs 16950 per months. Claimant Suresh claimed to have working with the respondents at the post of Security Guard with the respondent at the last drawn salary of Rs 26476 per months. They all demanded the legal facilities from the management but management has deprived them. Workman through their union had sent the demand letter dated 16/01/2018 to the management for regularisation of their services. But management had not reply. Union had filed their claim before the labour office . inspite of pending their claim with the labour department, management had terminated their services . Hence they had filed their clam before this tribunal with the prayer that they be reinstated with full back wages.

Management had appeared and filed their written statements. They denied the averments made by the claimant in their claim statement.

They had made prayer that claims of the claimants be dismissed. Issus have been framed in all these cases . Claimants are asked to lead evidence .

As per record claimant have not led any evidence despite providing a number of opportunities. Hence in these circumstances , when the claimants have not examined any witness to substantiate their claim, this tribunal has no option except to dismiss the claim of the claimants . Accordingly , claim of the claimant stand dismissd . Award is accordingly passed. File is consigned to record room. A copy the award is hereby sent to the appropriate government for notification under section 17 of the I.D. Act 1947.
