## **AWARD**

These are the two claims petitions filed by the workmen under section 2 (A) of the I.D. Act. Workmen claimed to have been working with respondent no.2 . as security guards at the last drawn salary of Rs 23154 and 23000 respectably. They were deputed with respondent no. 1 for performing for duties. Respondents were not providing legal facilities. There demanded legal facilities. Instead of providing the legal facilities, management started harassing them. Their services were terminated on 25/03/2019 illegally. They had sent the demand notice dated 17/04/2019 to the management but management had not replied. Hence they have filed the present claim petition

Management no. 1 had not filed any W.S. He was proceeded ex party vide order dated 02/05/2022. Management no 2 filed the W.S. denying the averments made by the claimants in their claims petition. Issues were framed in both the cases. Workmen were asked to examine the witnesses, however workmen have failed to bring any witness in the witness box despite providing a no. of opportunities. Therefore, this tribunal has no option except to dismiss the claims of the applicants. The claims are dismissed accordingly. File is consigned to record room. A copy of the award is hereby sent to the appropriate government for notification under section 17 of the I.D. Act 1947.
