AWARD

By this Composite order I shall dispose of these five cases filed by the claimant. These cases have been taken together for disposal because in all the cases respondent are same. Issues are also same. Only the workmen are different.

The workmen prayed for reinstatement with full back wages along with 18% of interest per annum. The case of the workmen are that they are working as electricians/helpers with the management i.e. AAI directly. The management orally assured the workmen for granting of all the legal benefits. The workmen had been working under the full control and supervision of management no-1. The management no-1 through forged document transferred the services of the workmen to the contractor. The workmen submitted their demand to the management. Thereafter, on 23.02.2019 the workmen removed from their jobs. He has initiated the conciliation proceeding but, no result. Hence, he had filed the present claim petition.

Management no-2, 3 & 4 have not appeared as such management no-2 & 4 were already proceeded ex-parte vide order dated 16th March 2020. However, the management no-1 has appeared and filed the W.S. He denied the averment made by the claimant in his claim petition. Issues have been framed in this case. Despite providing a number of opportunities, claimants have not appeared to substantiate his claim by filing the evidence by way of affidavit.

Hence, In these circumstances this tribunal has no option except to dismiss the claim of the claimants. Claim of the claimants stand dismissed accordingly. The copy of these awards are hereby sent to the appropriate government for notification under section 17 of the I.D. Act 1947.
