These seven cases have been filed under section 2-A of the Industrial Disputes Act, 1947 (**Hereinafter referred to as 'The Act'**), by the different workmen against the same managements. Having common respondents and same cause of action, these cases are being taken up together for recording the proceedings.

The Ld. AR for the claimants submits that a reference in respect of 16 workmen has been sent to CGIT-1 for adjudication by the appropriate authority, including these seven claimants, pertaining to their alleged illegal termination. He further submits that he wishes to pursue the said reference in place of the present cases filed under section 2-A of the Industrial Disputes Act, 1947.

In view of the submission made by the Ld. AR for the claimants, the present cases are dismissed as withdrawn. The award is passed accordingly.
