ORDER

This is an application filed by the LRs of the claimant Kuldeep Singh invoking the provision section 33(C) (2) of the Id. Act. praying a direction to the mgt to release the dues of her late husband Kuldeep Singh.

The management was noticed. After appearance when the mgt was called upon to file reply, the parties informed that an amicable settlement has been proposed and if the same is worked out the present proceeding alongwith Id. NO. 09/2016 filed by Kuldeep Singh (since dead and substituted by LRs shall stands disposed of.

Considering the same the matter was adjourned. On 13.02.2023 the wife of the deceased claimant Kuldeep Singh appeared and gave the statement in the tribunal and in presence of the A/R for the both the parties that she has already received a cheque of Rs. 5,49,142/- dated 10.02.2023 bearing cheque no. 444028 from the mgt toward the full and final settlement of the claim advanced by her late husband.

She further added the statement is being made on behalf of her children who too are the LRs of late Kuldeep Singh. She also stated that for the settlement arrived, there exists no dispute between the parties.

In view of the statement of the claimant this order is being passed and the LCA stands disposed of. Hence ordered.

The LCA be and the same is disposed of on full and final satisfaction of the applicant and this order is accordingly passed and forwarded to the parties.
