This Tribunal is of the considered opinion that any delay caused due to the circumstances faced by the Counsel is not attributable to the party and thus, should not affect the legal rights of the party, filing the case.

It is expected from the Respondent authority, not to take coercive measures for recovery of the amount as mentioned in the impugned order till next date of hearing.
