The Ld. Counsel for the Appellant today submitted that the present appeal needs to be restored as directed by Hon'ble Delhi High Court in W.P.(C) no. 6278/2016 vide order dated 26.08.2019 wherein the following directions were issued:-

*The record shows that pursuant to the order dated 31.07.2017 passed by this Court, the petitioner has already deposited before this Court 50% of the amount as directed to be deposited before the Tribunal under the impugned order.*

*Mr. Puneet Khanna, Legal Manager of the petitioner submits that instead of continuing to pursue this writ petition, the petitioner is now willing to comply with the impugned order and deposit 40% of the assessed amount before the Tribunal, so that its appeal can be heard on merits expeditiously.*

*Learned counsel for the respondent does not oppose the said request.*

*In view of the aforesaid stand taken by the petitioner, the amount already deposited by the petitioner before this Court is directed to be forthwith refunded back to the petitioner with upto date accrued interest thereon. Subject to the petitioner depositing with the Employees Provident Fund Appellate Tribunal within four weeks, the amount as directed under the impugned order dated 27.04.2016, the Tribunal is directed to consider the petitioner's pending appeal being ATA No. 525(4)2016 on merits.*

*The writ petition is disposed of in the aforesaid terms.*

The Ld. Counsel for the Appellant submitted that the amount of Rs.32,40,400/- and Rs.32,40,309/- stands deposited with this Tribunal by way of Demand Draft no. 061307(dated 01.11.2019) and 013137(dated 04.12.2019) respectively favoring 'Registrar CGIT'.

The Registry of this Tribunal is directed to put-up an office note showing the date of credit of the above Demand Drafts in the respective account of this Tribunal. List the matter on 05.12.2022 for consideration of the office note and further proceedings.
