- 1. Appellant has preferred the appeal assailing the impugned order dated 20.05.2022 where the ld. RPFC has assessed the dues to the tune of Rs.53,15,308/- as EPF dues u/s 7A of the EPF & MP Act, 1952 (hereinafter referred as the Act). He has assailed the said order stating that the exparte order has been passed by the ld. RPFC order as no person on behalf of the appellant establishment was present during the course of enquiry. He submitted that matter be remanded back to the RPFC for fresh consideration and he be given opportunity to present his case. Ld. Counsel for the respondent has opposed the prayer however, he has admitted that ex-parte order has been passed.
- 2. I have heard the counsel and perused the impugned order in question. In the order dated 20.05.2022, enquiry was initiated for the period 03/2012 to 04/2017 and it was also reported in the order that during the visit of Sh. Vipin Batra, Area Enforcement Officer on 15.11.2021 and 17.12.2021, he found that the establishment was lying closed for a long time. Even one director was tried to be contacted but his phone was showing switched of. Therefore, on the basis of record available in the compliance file, he had assessed the dues.
- 3. Considering the above fact that appellant has not participated in the enquiry after which impugned order dated 20.05.2022 was passed on the basis of available record, the order dated 20.05.2022 is recalled and set aside. Appellant is directed to appear before the RPFC-Meerut on 23.06.2025 at 12:30P.M. Attachment order which has already been passed by the ld. RPFC in respect of property in question has been untouched and the same is kept in abeyance.
