This is a fresh appeal which is filed against the order passed u/s **14B of the EPF & MP Act, 1952** by respondent department whereby an amount of Rs.23,90,487/- is assessed as damages for the belated payment of dues.

The proxy counsel appearing on behalf of the appellant submits that the main counsel Sh. Vivek Kaushal, is not available because his father has expired today in the morning.

Ld. Counsel for the respondent submits that he will file the tracking report to establish the fact that impugned order was communicated to the appellant much prior to the date which he has averred in the application.

Record perused. An application for condonation of delay has been filed by the appellant mentioning that he has come to know about the order only on 24.07.2025 on receipt of the demand notice issued by the recovery officer. Thereafter, he has filed this present appeal on 14.08.2025 which is within the period of limitation.

Let the matter be listed on 16.09.2025 for hearing on the misc. application filed condonation of delay.
