This tribunal vide its order dated 17.07.2025 had directed the Appellant to deposit an amount of Rs.25,00,000/- by way of FDR as a condition for stay on recovery of the amount mentioned in the impugned order.

In par compliance of the said order dated 17.07.2025, Ld. Counsel for the appellant had deposited an FDR amounting to Rs.10,00,000/- on 11.09.2025 and had sought time till today for depositing the balance amount of Rs.15,00,000/-.

direction to supply the advance copy to the opposite party. Put up for 03.12.2025 for final argument.
