Record perused. The appeal has been filed assailing the order passed by the respondent u/s **7A of the EPF & MP Act, 1952 (hereinafter referred as the Act)** wherein amount has been assessed by the respondent to the tune of Rs.15,41,379/- as PF dues. On 19.09.2025, application u/s 7O of the Act was disposed off directing the appellant to deposit an amount of Rs.6,00,000/- within six weeks from the date of order by way of **FDR favouring 'Registrar CGIT'** as a condition of pre-deposit as mandated under Section 7O of the Act.

Instead of complying, the order in letter hand spirit, appellant had moved a misc. application seeking time for deposit of balance amount after making the part compliance of Rs.3,02,000/- by way of FDR which was not found in terms of order dated 19.09.2025 and the same was returned to him for complying the order dated 19.09.2025 till today. However, no compliance has been made by the appellant.

Since the appellant has failed to comply with the condition imposed by this tribunal which is mandated u/s 7O of the Act for entertainment of the appeal, this appeal stands dismissed on non-compliance. Respondent is at liberty to execute the order and recover the amount as per rules. Office is directed to consign the record to the record room.
