This is a fresh appeal filed by the Ex director of **M/s Novex Pvt. Limited** assailing an order dated 13.08.2025 passed by the respondent authority **u/s 7A of the EPF & MP Act, 1952 (hereinafter referred as the Act)** whereby an amount of Rs.38,36,732/- has been assessed as EPF dues for the period 06/2017 to 06/2019. Appellant has stated that the company **M/s Novex Pvt.Limited** has gone into liquidation and entire assets have been divided amongst the various stake holders. He further prayed that the EPF Authorities along with others have been given a notice, however, the claim filed twice by the EPF Authorities was rejected by the RP and the EPFO had not initiated any further legal proceedings either before the NCLT, NCLAT or any other legal forum. His further case is that the employees of the appellant establishment went to Delhi High Court by filing a writ and the writ petition was disposed off by the High Court giving directions to EPFO to look in the matter and dispose off the claim in accordance with the provision of EPF & MP Act, 1952. Upon the strength of this order passed by High Court, EPF Authority has initiated the enquiry and passed the impugned order.

Respondent counsel submits that the order has been passed in accordance with the law and in compliance of the direction by the High Court. Since, it is an order passed against a non-existing company and the account of the Ex director has been attached, therefore, the respondent authority not to take any further coercive action against the appellant

herein till the further disposal of the misc. application filed u/s 70 of the Act.

Ld. Counsel for the respondent seeks some time to file the reply to this misc. application. Put up this case on 11.11.2025 for filing of reply to the said application and arguments on the same.
