These are the three cases filed by the appellant against the respondent. One is **u/s 7A of the EPF & MP Act, 1952 (hereinafter referred as "the Act")**, remaining two are u/s 14B & 7Q of the Act. Respondent had filed short affidavit in Hon'ble Delhi High Court in response to the writ petition bearing no. W.P. (C) 5630/2020 wherein he had mentioned that four orders have been passed three u/s 7A of the Act and one u/s 14B & 7Q of the Act. However, only one order passed u/s 14B & 7Q of the Act amounting to Rs.1,87,41,227/- is on record. So far so the remaining two orders passed u/s 7A amounting to Rs.9,72,71,063/- dated 29.08.2019 & issued on 30.08.2019 as well as another order passed u/s 14B & 7Q of the Act amounting to Rs.29,68,119/- are concerned, the record is not traceable. Even, this file is not in possession of the respondent. Respondent is directed to trace the record and take disciplinary action against the concerned person who is responsible for keeping record.
