The matter came up today on account of a petition filed by the appellant for early hearing. The Ld. Counsel for the respondent submitted that he is ready for hearing on admission and application filed u/s 7O of the EPF Act. Matter was heard being argued by the counsel for both the parties. The Ld. Counsel for the appellant submitted that the impugned order was passed on 06.05.2022 and the appeal was filed on 22.06.2022. Thus, the appeal has been filed within time. But the EPFO before expiry of the appeal period initiated the proceeding u/s 8F of the Act and attached the bank account which has posed serious difficulty for the appellant in running the business. Hence, he submitted that an order need to be passed pending admission of the appeal for deattachment of the bank account. The Ld. Counsel for the respondent counter argued that the proceeding u/s 8F was started after expiry of the limitation since the passing of the order u/s 7A of the Act. But perusal of the record shows that challenging the order passed u/s 7A the appellant had filed an application u/s 7B of the Act which was disposed of by order dated 06.05.2022 and within a period of 60 days since then the appeal was filed. But the EPFO ignoring the right of the appellant to appeal have initiated the proceeding u/s 8F and have attached the bank account of the appellant maintained with Yes Bank Plot No. 11/48 Shopping Centre Block C Chankyapuri New Delhi bearing account No. 000380200004256. Since, the act of the respondent in attaching the Bank account of the appellant is in gross violation of the statutory right of the later it is directed that the respondent shall issue direction to the bank concerned to de attach the bank account forthwith and shall not recover the assessed amount till admission of the appeal and disposal of the application filed u/s 7O of the Act. The argument on admission and the application u/s 7O being complete list the matter 08/08/2022 for passing of the order.
