**ORDER**

The record has been put up today for hearing of the petition filed by the claimant invoking the jurisdiction of the Tribunal under Rule 28 of the Industrial Dispute (Central ) Rule 1957 praying therein that an award has been passed by this Tribunal infavour of the workman directing the management bank for reinstatement into service alongwith 50% back wage. But in the body of the award due to inadvertence the address of the management no.2 Indian Overseas Bank , Branch, Indirapuram, 1/3 Vaibhav Khand, Amarpali Green, Indirapuram, Ghaziabad, and designation of the claimant Temporary

Messenger / Sweeper has been mentioned, which should have been mentioned as Indian Overseas Bank, Branch Navyug Market, Ghaziabad(U.P.) and designation should be Record Keeper/Daftri. Unless these clerical errors would be corrected serious prejudice shall be caused to him.

Perusal of record shows that the claimant in his claim statement as well as in his affidavit evidence mentioned the address Indian Overseas Bank, Branch Navyug Market, Ghaziabad(U.P.) and designation as Record Keeper/ Daftri. A Mistake has occurred in the preparation of the award. Rule 28 of the Industrial dispute (Central )Rule 1957 empowers the tribunal to correct any clerical mistake or error arising from an accidental slip or omission in the award. Considering the circumstances of this matter this Tribunal feels it proper to exercise the jurisdiction for correction of the error on the face of the award. Accordingly it is directed that the address of the management no. 2 mentioned in page no. 1 of the award be read as Indian Overseas Bank, Branch Navyug Market, Ghaziabad(U.P.) in place of Indian Overseas Bank , Branch, Indirapuram, 1/3 Vaibhav Khand, Amarpali Green, Indirapuram, Ghaziabad and the designation of the claimant in page no. 1, 2<sup>nd</sup> para, 2<sup>nd</sup> line , page no. 3, para III, 2<sup>nd</sup> line , be read as Record Keeper/Daftri in place of Temporary Messenger/Sweeper.

All the other things remaining unchanged. The order be sent to the Appropriate Government for publication of a corrigendum of the award.
