(JUDGMENT)

(Passed on 03rd day of February, 2026)

The workman has filed this petition seeking modification of Award/Judgment dated 12.09.2024 passed by this Tribunal in the case RC/04/2016. I have heard argument of Learned Counsel for the award holder petitioner Praveen Yadav seeking review and Learned Counsel for the OP Management Shushma Pandey who has filed reply to the petition with affidavit and have gone through the record. By the review petition, the Award holder seeks correction in his name which was Karu @ Karan and substituted it as Kaliyan S/o Sampatiram.

Main objection is that *firstly*, there is no provision for review of an Award and *secondly*, it is not established that the person Karu @ Karan who filed the petition and the person whose name is Kaliyan S/o

Sampatiram being such to be substituted in Award are one and same person.

As regards the first objection, no doubt an Award cannot be reviewed by this Tribunal who has passed it, but clerical and arithmetical corrections may be rectified.

In the case in hand, the petition was filed in the name of Karu @ Karan S/o Sampat resident of Shri Krishna Colony Ahead of Virendra Vatika., Lahar Road, Bhind (M.P.). In the judgment and Award also this name was mentioned. Now, by the way of review petition, modification in the name is sought as Kaliyan S/o Sampatiram which is mentioned in the Adhar Card and Voter Id. Learned Counsel for the petitioner submitted that in fact Karu @ Karan and Kaliyan S/o Sampatiram are one and same person and the petitioner is not able to get the benefit under the Award due to difference in his name in his Adhar Card and the Award, this requires to be rectified. This submission could not be accepted that the petitioner/applicant is at liberty to get either his Aadhar card correct or establish before the Management that Karu @ Karan s/o Sampat and Kaliyan S/o Sampatiram are one and same person. With these observations the petition stands disposed off.
