- 1. These are the cases listed for disposal during the special campaign conveyed by the Ministry of Labour and Employment vide letter dated 14.02.2025. This tribunal has fixed the two dates for special campaign for disposing of the appeal under the EPF & MP Act, 1952 as well as Industrial Dispute Act, 1947.
- 2. Today the counsel appearing for the respondent accompanied with the officials of the respondent department have stated that they have no instructions from the department for reducing the damages levied by the authority.
- 3. It is important to mention here that the letter addressed by Sh. Dhananjay Sharma, Under Secretary, Ministry of Labour and

Employment, on behalf of the Govt. of India, had requested all the CGITs including the undersigned to fix the date of special campaign in this tribunal and issue necessary notice to the parties. Copies have been forwarded to the CLC and it was requested that all the Regional Offices of Dy. CLC be directed to consult the Presiding Officer CGIT Cum Labour Court for listing out the cases to be heard during the special campaign. The same language has been employed in respect all the Regional offices of the EPFO. However, no consultation took place as no one has appeared for consultation and listing out the case.

- 4. It is also important to mention here that in pursuance of the special campaign, office of the RPFC, Gurgaon East has sent the list of cases to be listed and therefore, the notice were issued in these cases. The submission of the counsels appearing on behalf of the respondent are that they are in utter confusion regarding the listing of the cases in special campaign or the cases to be heard expeditiously and for that the list has been sent by EPFO Regional Office Gurgaon East to this tribunal.
- 5. It appears that it is only the defence created by the respondent just to circumvent and derail the whole exercise of launching the special campaign for reducing the pendency of the appeals in the tribunal. In these circumstances all the Regional Provident Fund Commissioners in the jurisdiction of this tribunal are directed to appear in person to explain as to what consultation from this tribunal has been taken place in pursuance of the letter issued to them by the Ministry Of Labour And Employment.
