- 1. These above said officers have been called by this tribunal to give explanation as to why they have not consulted the undersigned in spite of giving direction issued by the Ministry of Labour and Employment through Under Secretary Sh. Dhananjay Sharma for taking up the cases in the special campaign for disposal of the appeals filed against the order passed u/s 14B of the EPF & MP Act, 1952.
- 2. It is also important to mention here that the special campaign scheme had been launched by the Ministry of Labour and Employment for settling the Industrial dispute as well as Provident Fund appeals pending before this tribunal. Provident Fund appeal has been taken only for the cases filed against the order passed by the respondent u/s 14B of the EPF & MP Act, 1952 as amount involved pertains to damages which is used to be deposited with the respondent department



as penalty without incurring and depositing in the account of EPF subscribers.

- 3. Submission of the all the Regional Provident Fund Commissioners is that they have written to their respective Zonal Offices regarding the meeting called by this tribunal on 08.01.2025. Since, the reply has not been received, they have stated before this tribunal on 5th and 7th March, 2025 respectively that they have no instruction. In this background, all the special campaign launched by the Ministry of Labour and Employment had been derailed.
- 4. It is also important to mention here that all the RPFC officers has not adhered to inform the tribunal about the communication/information regarding the non-receipt of any instructions from the zonal office either on 17.01.2025 as stated by under signed in the meeting or on any other date. Subsequently, despite of being informed about the special campaign, no information is provided to this tribunal by the concerned officers.
- 5. It is also important to mention here that the decision making authority of the EPFO is vested in the Central Board of Trustees. Hon'ble Minister of Labour and Employment is the Chairman of CBT. Secretary, Ministry of Labour and Employment is the ex-officio Secretary of the CBT and Central PF Commissioner is the Chief Executive Officer of the CBT.
- 6. In these circumstances, a copy of this order be sent to the Central Provident Fund Commissioner with the request to place the proposal for reducing the damages to the Central Board of Trustees considering spirit of the meeting conducted on 19.12.2024 in the Ministry of Labour & Employment under the chairmanship of Dr. Manshukh Mandaviya Hon'ble Cabinet Minister so that the speedy disposal of the appeal u/s 14B be made. Decision be taken as earliest for reducing the pendency of the appeals.
